I have carefully reviewed and understand the above provisions and agree to be bound by them. I agree that I shall have no claim against Pentathlon Ontario or Pentathlon Canada for the use of the image.

COMPETITOR CODE OF CONDUCT.

The code of conduct outlines the expectations regarding and discipline from inappropriate behavior.

Athlete's obligations:

- 1. Prepare to do your best performance prepare physically and mentally for every pentathlon.
- 2. Avoid any action or conduct that would disrupt or interfere with a competition or the training preparation of any athlete for a competition.
- 3. Maintain a high standard of behaviour, respect and sportsmanship at all times.
- 4. Obey schedules and punctuality for events.
- 5. Avoid any prohibited substances: alcohol, illegal drugs and any drugs banned or restricted by the IOC, UIPM, Sports Canada and Pentathlon Canada.

Inappropriate behaviour includes, but is not limited, to the following activities:

- Unsportsmanlike conduct,
- Swearing,
- Misleading information on skills level,
- Inappropriate use of the equipment.

Any contravention of the above obligation will be dealt with seriously and may result in any or all of the following:

- Verbal warning,
- Written warning,
- Suspension from current competition/training,
- Suspension from future competitions/trainings.

The final decision of the course of action will be determined by the designated competition/training technical coordinator.

If a decision is being made to suspend an athlete from future competition/training events, a recommendation will be made by the event technical director to the Pentathlon Ontario – Technical Director, who will make the recommendation. Appeals for this decision may be made to the President of Pentathlon Ontario in writing.



PENTATHLON ONTARIO COMPETITION WAIVER

Waiver covers all events (competition and training) officially sanction by the board of Pentathlon Ontario.

I am aware that modern pentathlon involves many inherent risks, dangers and hazards, including but not limited to, the use and operation of air pistols, fencing equipment, equestrian equipment, horses and obstacles, cross country running terrain and associated hazards, and swimming, negligence on the part of event organizers, event volunteers, coaches, other athletes and spectators.

I freely accept and fully assume all such risks, dangers and hazards and the possibly of personal injury, property damage or loss resulting from such risks, danger, and hazards. In consideration of Pentathlon Ontario allowing me to take part as a manager, coach or athlete in the modern pentathlon competitions, whether they are local, provincial, national or international, I hereby agree as follows:

- 1. To assume and accept all risks, dangers and hazards in connection with my participation in, and travel to or from, the competitions/training events;
- 2. To waive any and all claims that I may have against Pentathlon Ontario and Pentathlon Canada;
- 3. To release Pentathlon Ontario and Pentathlon Canada from any and all liability for any loss, damage, injury or expense that I, or my next of kin, may suffer or incur as a result of my participation in, and/or travel to or from, the competitions/training events, due to any cause whatsoever, including negligence on the part of Pentathlon Ontario/Pentathlon Canada;
- 4. To hold harmless and indemnify Pentathlon Ontario/Pentathlon Canada from any and all liability for property damage or personal injury suffered by myself or by a third party as a result of my participation in, and/or travel to or from, competitions/training events.

I have read and understand this waiver prior to signing it and am aware that by signing this document, I am accepting the terms of this waiver and am thereby affecting the legal rights and liabilities of myself, my family, administrators and assigns in relation to Pentathlon Ontario/Pentathlon Canada.
